POLICY INITIATIVES : LEVERAGING THE POWER OF POLICIES TO BRING THE AGRICULTURAL TRANSFORMATION

Dr M J Khan, Chairman, Indian Chamber of Food and Agriculture

extended a warm welcome to the panellists. He talked about India's "new found confidence" after the commendable achievement of crossing the \$50 Billion mark in agri export. However, he cautioned that the road ahead is a long one and there are several milestones that India is yet to achieve. Talking about Agri exports, Dr Khan pointed out how this subject is of importance at the state level, as there is little progress possible without due contribution from the states. He underlined the need for maintaining the numbers India has successfully achieved in Agri Exports. Quality, he said, is a crucial component in terms of exports since quality production plays a key role in developing and meeting demand for the items produced. He also discussed the crucial role that APEDA, as an organisation, has had in this enormous achievement.



Dr Sudhir Kochhar, Former ADG (IPR) and National Coordinator (NAIP),

ICAR pointed out that India has a diverse climate which contributes towards a diverse production. "We have the ability to be able to produce a wide range of products for not just our consumption but also for export across borders. Our Basmati rice, for instance, is premium in quality and better than most regions".



Dr JP Mishra, ADG- Policy, ICAR

pointed out that in terms of agricultural exports, India has experienced tremendous growth. This was made feasible by a concerted effort and a variety of agricultural policies. "Real-time analysis must be prioritised in order to maintain or improve our export position. It is also necessary to have a thorough awareness of the market, as success is impossible without understanding the market. Structural changes must also be promoted," he recommended.



Prof. M.Moni, Chairman ICFA, Working Group on ICT and Former DG, NIC

brought the attention to India's more than 400 agricultural commodities which is a huge number for any country. According to him with the right amount of effort and measures India can continue to excel in exports of agricultural products. "Productivity and quality of the products are of utmost importance".



Mr R Ramakrishna, GM Delhi, NABARD

emphasized on the need to focus on the uniqueness every region across India is blessed with, and that it can yield a wide variety of good quality products. "Productivity and progress in agriculture go hand in hand, and require proper attention. Policies that promote Agricultural productivity are essential too," he pointed out.





Mr. Anup Kalra, Executive Director, Ayurvet

talked about the need to provide focused attention towards the productivity in India. It is very important for not just India's performance in export but to meet the requirements of the millions of people like we do.
