He also talked about encouragement of youth in order to get engaged in agribusiness, encourage farmers and develop partnerships with private sectors considering productivity and enhancing nutritional security.

mentioned that modern science is going very far from the nature. Ecological sustainability and ecosystem based agriculture are the concept of ones health that includes human world, animal world and plant world. Session 1: Policies to Power Farm Growth

Dr. Poonam Malakondaiah

Special Chief Secretary, Government of Andhra Pradesh chaired the session and presented the presentation on YSR Rythu Bharosa program launched by the Government of Andhra Pradesh to financially assist farmers by depositing an amount of Rs 13,500 per annum in three instalments, in association with Pradhan Mantri Kisan Samman Nidhi with the state government contributing Rs 7500 and the center Rs 6000.



Mr. RL Tamak

CEO, Sugar Business, DCM Shriram Ltd commenced the session and emphasized on ethanol blended petrol programme. He said that in the year 2013-14, ethanol supplied for blending was only 38 crore litres, whereas in 2014-15, under the modified EBP supplies increased to 67 crore litres and also talked about benefits to farmers as it empowers farmers and it is environment friendly which helps in reducing pollution.



Dr. Elizabeth Saipari

Director of Horticulture, Mizoram discussed regarding the agricultural problems in Mizoram and



achievements of the state government to combat those problems. She said that North eastern states including Mizoram has high horticulture potential but the problem is uneven topography, fragmented and scattered cultivation, difficult to organize farmers to get together, no processing units in the state, cost of production is high, problem of post-harvestlossetc.

Mr. RK Chitkara

Group Advisor, ICFA talked about farm growth and difference between agribusiness and agriculture. He said that such policies should be formulated which helps in more earning of money for the sustenance of families of farmers and also which encourage them to remain engaged in agriculture.





Session 2: Technologies to Transform Agriculture

Ms. Annalisa Zezza

Agriculture & Food Attache, Embassy of Italy chaired the session and emphasized her words on to build the capability of education and training in order to build innovations and technologies in strong



frameworks. She also considered that the farmers should be provided with proper incentives in order to practice sustainability. The major challenge according to her for the sector is computer illiteracy that needs to be overcome.

Mr. Sachin Bandwana

Cofounder, Bighaat opened the session and emphasized on the innovation in technologies to level up and transform the agriculture. He stated that farmers should get the right information, right and high quality inputs, end to end crop guidance and market linkages for various commodities. He further detailed about their organization which is India's



largest Agri Inputs digital marketplace platform, released a comprehensive agri input stack backed by the robust network of satellites, agronomists & farmers with an aim to deliver autonomous surveillance & crop care in real time. This facility lets the farmer visit their farm, click an image and upload via the 'Crop Doctor' feature of the BigHaat app. The Al technology then advises the best practices, most suitable inputs & offers dynamic assistance in real time to the farmers. This unique approach is aimed towards automating cropcare across India, giving the farmers a reliable full stack farm management approach. BigHaat has connected the farmer community with Kisan Vedika, a Facebook-styled social media facility for farmers' where they can ask their queries in regional languages and expect endto-end guidance by their team of agriculture experts. This is the platform to bring all the stakeholders together.

Mr. Agam Khare

Founder, Absolute commenced the talk by mentioning the significant role played by science and technology in agricultural sustainability. He also stated that its not only artificial intelligence but



nature's intelligence that leads to sustainable agriculture and the absolute is based on this only. There were also certain discussions about how agriculture flourished after Bengal famine and the role of national food security.



Prof. C. P. Suresh,

HOD Horticulture, NEHU expressed his concern regarding water depletion and water available for agriculture. He talked about different water percentage available for different usage. He made acquainted with different irrigation method including drip and sprinklers. Ge introduced sensor based irrigation technology, where sensors can sense the amount of water required by plants, which in turn minimises the water loss. He ended his words saying Innovation and new technology can help to maintain the agriculture sustainable.



The session also discussed about how milk production is booming in the country. Milk if considered crop is one of the biggest crops. Around 40% farmers in India have cows which helps them earn a better livelihood through milk production. The focus needs to be put on Indian dairy sector and how one could help the famers to tackle the challenges related to dairy. It should also have suggestions and solutions on how the farmers should practice farming along with dairy practices.





Session 3: Trade to Empower Farmers

Mr. Baldev Prakash

MD & CEO, JK Bank opened the session and discussed about the significance of JK bank that how it is playing a dominant role and leading to transformation in economy of J&K union territory. He



further elaborated regarding the bank's contribution in boosting agricultural economy and its main objective to provide adequate and timely credit for comprehensive requirements of farmers with flexible and simple features.

Mr. Aleen Mukherjee,

COO, NCDEX commenced the session and detailed about their organization first that it is the largest online commodity and derivative exchange and works for over 400 FPOs in India. He stated that India occupies a leading position in global trade of agricultural products and it is one of the largest agricultural product exporters in the world but the



major problem faced by Indian agricultural market is market price determination for farmers for which NCDEX is working on as it assists Indian farmers in the price discovery process. It enables them to price their goods more accurately even if they are not active in the futures market. He also emphasized that technology is the solution for farming problems and demand and supply balance is to be maintained in the market. He finally talked about Agriculture Infrastructure fund to create the infrastructure for post-harvest management.

Mr. Maharaj Muthoo

President, Roman Forum, Rome emphasized on the fact that farmers should not be allowed to work as slave anywhere in the world.

Dr. Rahul Pandey

Dean, Imperial School of Agri Business discussed regarding how the technology will reach the farmers. He emphasized upon the empowerment of youth.

Dr. Prathapan,

VC, DY Patil University commenced the session with the mentioning of Kerala as Land of Ayurveda. He also talked about the empowering of women in every field.

Chairperson, AP Seeds- she talked about seed being the basic of agri. We should use the quality seeds so that the productivity incurred from the input is better in terms of quality and nutrition. The seeds should be free from inert matter and we should ensure that quality seeds should be provided to the farming community. Seeds testing labs should be set all over the country and regular testing of seeds

Dr. Arvind Kapur

CEO, Ascen HyVeg Seeds P. Ltd.- he talked about different sectors of investment in seeds and plant breeding centres. He mentioned the data that at present, in India there are about 3.6 mn investment in total seed industry which makes India stand 4th in the que after USA and china. Most of the investment are coming from private sector. He put forth a suggestion that investment should now be done in upstream phase and breeding phase. He mentioned that it is both policy and approach that makes the contribution of the breeders towards plant breeding.



Mr. Shekhar Babu Geddam

IFS Vice Chairperson and Managing Director, AP Seeds- he made the audience acquainted with the changing scenario of public sector and the changes witness from last decade to the present. He laid emphasis on to enhance productivity which will further enhance the nutritional security. There should be equal participation of all the sectors including public and private in order to improve variety so that both the sectors have the credibility of what inputs they are providing to the input sectors. He laid emphasis on the need of the hour to solve the problem of farmers which In turn can help to withstand the hunger and decrease the death rate.



All the inputs including fertilizer and mineral nutrition should be made available to them so as to enhance productivity.
